Chief (ret.) Kevin M. Cashen Assessor

Currently, Chief (ret.) Kevin Cashen is a full time professor with Tiffin University in Tiffin, Ohio teaching criminal justice and homeland security courses. Chief (ret.) Cashen was employed with the Norwalk, Ohio Police Department from 1984 to 2009. Chief (ret.) Cashen held various positions within the Norwalk Police Department to include patrol officer, detective, sergeant, captain, executive officer and chief of police. Chief (ret.) Cashen earned a B.A. in Criminology and Criminal Justice from The Ohio State University, a Master of Criminal Justice from the University of Alabama and a Master of Arts in Security Studies (Homeland Security and Defense) through the U.S. Naval Postgraduate School. In the 1990's Chief (ret.) Cashen was an adjunct professor with Ashland University, Ashland, Ohio and from 2006-2009 an adjunct professor for the University of Maryland University College teaching courses in criminal justice and homeland security. Chief (ret.) Cashen attended the FBI National Academy in 1998 and has been a Certified Law Enforcement Executive through the Ohio Association of Chief of Police since 1998.

In his former capacity, Chief (ret.) Cashen was a member of the Certified Law Enforcement Executive Board with the Ohio Association Chiefs of Police, Huron County Community Corrections Board Member, Huron County Advisory Board Member for Domestic Preparedness and Homeland Security, Huron County Emergency 9-1-1 Committee Member, Huron County Local Emergency Planning Committee Member, Terra Community College Law Enforcement Advisory Board Member and the Ohio Homeland Security Region 1 Law Enforcement Response Coordinator.

Currently, Chief (ret.) Cashen is a consultant through the Ohio Association of Chiefs of Police Advisory Services, a member of the Ohio Police Chief Magazine Publications Committee, serves on the Norwalk Area United Fund Board, the Norwalk Area United Fund Budget and Admissions Committee, the EHOVE Public Safety Advisory Board, the CROSSWAEH CBCF Facility Governing Board, the Tiffin University Student Retention Committee, is the faculty advisor to the Tiffin University Debate Club and is Chair of the Tiffin University Curriculum Committee. Chief (ret.) Cashen has been a volunteer basketball coach with the Norwalk School District since 2005.
